DOUBLE DEGREE WITH THE UNIVERSITY OF TWENTE

Overview

The Double Degree in Business Administration, Economics and Finance is a **cooperation between the University of L'Aquila** (Italy) **and the University of Twente** (The Netherlands).

It is a 2nd cycle degree programme (Laurea Magistrale / Master of Science) on the topics of business administration and management, with a focus on human resource management.

Completing this two-year programme (120 ECTS) will result in **two degrees**:

- 2nd cycle Degree in Business Administration, Economics and Finance (LM 77), major in Management, from the University of L'Aquila;
- Master of Science in Business Administration (English-taught), major in Human Resource Management, from the University of Twente.

The programme is open to students enrolled at the University of L'Aquila in the first year of the 2nd cycle Degree Programme (Laurea Magistrale) in Business Administration,

Economics and Finance, major in Management.

The main **benefit for students** is earning two degrees in less time than what would be necessary to complete the two programmes separately. Furthermore, the Double Degree provides students with a unique learning experience in two different countries, within a diverse and multicultural environment.

The **programme is structured** as follows:

- The first year is carried out at the University of L'Aquila (L'Aquila, Italy);
- The second year is carried out at the University of Twente (Enschede, The Netherlands).

The final thesis, written in English, will be one for both institutions and will be supervised jointly, by at least one supervisor from the University of Twente and at least one from the University of L'Aquila.

In order to earn the Double Degree, students will have to be in compliance with both their home and host universities' rules with regard to credits, attendance, deadlines etc.

Learning objectives

The programme provides a challenging training in the key areas of management and business administration in global contexts, with a focus on human resource management. Students learn how to

integrate knowledge in international business and human resource management into the context of industry and economy-wide issues in order to deal with complex management problems in changing organizations and

markets. The programme provides specialist HR expertise, as well as broader business and interpersonal skills.

The **teaching approach** is interactive and combines several teaching methods, including group project works, case studies, role-plays, business games and simulations.

- A low teacher-student ratio, facilitating tailored feedback
- The combination of academic rigour and practical relevance
- Interactive teaching methodologies that foster students' engagement
- Advanced knowledge and expert skills in business administration and human resource management
- A focus on leadership skills and soft skills development
- Cross-disciplinary perspective that approaches topics from various academic angles
- Learning experience in two different countries, within a diverse and multicultural environment

Employment and professional opportunities

The Double Degree programme in Business Administration, Economics and Finance opens up a wide range of career opportunities. Graduates gain both the technical/methodological knowledge and the international experience suited to pursue professional and managerial careers in large corporations dealing with international and multicultural issues, as well as in small and medium sized companies implementing international processes.

The programme emphasizes the strategic role that human resources play in the performance of contemporary organizations, providing students with the knowledge and

skills needed to developing into a skilled HR professional and HR manager, with the ability to apply strategic thinking to analyse business situations and effectively manage human and knowledge capital.

This Double Degree course also prepares students for qualified HR roles in consulting firms, banks and insurance companies, government and public service organisations. This Double Degree course serves as an excellent stepping stone for those wishing to undertake doctoral studies in management or industrial and organizational psychology to pursue academic careers and qualified roles in research institutions.
